

# Suite Sweepstakes

## OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

**Sponsor Information:** Suite Sweepstakes ("Sweepstakes") is Sponsored by Greater Nevada Credit Union (GNCU) ("Sponsor"), P.O. Box 2128, Carson City, NV 89702.

**Eligibility:** The Sweepstakes is open to existing GNCU business members. Employees of the Sponsor, and any or all subsidiaries, affiliates, advertising and promotion agencies, retailers, distributors (collectively with Sponsor, the "Released Parties"), and their immediate family members and/or those living in the same household are not eligible to enter or win. Immediate family members are defined as a parent, spouse, sibling, child or anyone sharing the same residence as the applicable employee. By participating, entrants agree to be bound by these Official Rules as may be modified or amended by Sponsor, and the decisions of the Sponsor, which are final and binding. Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited by law.

### **How to Enter:**

Current GNCU business members will automatically receive one (1) entry for every new GNCU business member referral successfully completed. A successful referral requires the new business member to open a new GNCU Commercial Share Savings account and their choice of business checking account, and all accounts must remain in good standing after 60 days from the open date.

Entrant must complete the process in its entirety as described above in order to be entered into the Sweepstakes. All entries must be completed between 12:00 a.m., Pacific Time ("PT") on August 19, 2024, to 11:59 p.m. PT on October 19, 2024 ("Entry Period"). Sponsor is not responsible for lost or late entries.

### **Prize:**

Sponsor will award the following prize during the Sweepstake ("Prize"):

- One (1) Grand Prize winner will win the opportunity to watch their choice of a weekday game (Monday – Thursday) in April or May 2025 from Sponsor's suite at Greater Nevada Field. Includes 20 game tickets. Approximate retail value ("ARV"): \$2,100

If the actual value is less than the stated ARV, difference in Prize value will not be awarded. Additional terms and conditions may apply. Such terms will be provided at the time the Prize is awarded. Any Prize details that are not specified above will be determined by Sponsor, in its sole discretion. Gratuities, upgrades, and any other expenses not specifically listed herein are the responsibility of Winner.

### **Selection of Winner:**

Subject to further verification and compliance with these Official Rules, Terms and Conditions, the Prize will be awarded as follows:

- The Winner of this Prize will be randomly selected by Sponsor on December 20, 2024, from all eligible entries received in the Entry Period. Winner will be notified via a telephone call to the telephone number associated with their GNCU member account. If the potential prize winner (i) does not respond to the winner notification by 12:00 p.m. PT on December 31, 2024, (ii) is otherwise found to be ineligible, or (iii) cannot accept or receive the prize for any reason, the potential prize winner will forfeit the Prize and the Sponsor may select a new potential winner in its sole and absolute discretion.

ENTRANTS NEED NOT BE PRESENT TO WIN. The odds of winning any Prize will be determined by the number of entries. A potential winner's Member account(s) with Sponsor must be in good standing at time of selection to qualify to win a Prize. The Sponsor reserves the right to modify the notification procedures in connection with the selection of an alternate winner, if any. A Prize may not be transferred and must be accepted as awarded. A Winner may not request cash or a substitute Prize. No cash or other substitution of Prizes is permitted, except at the sole option of Sponsor for a prize of equal or greater value.

**Sweepstakes Taxes:**

**Release:**

By entering, entrants agree to release, waive, and hold harmless the Released Parties from and against any and all claims, losses, damages, and liability arising from injuries (including death), damages, costs, or expenses of any kind (including without limitation attorneys' fees) incurred as a result of the entrant's participation in this Sweepstakes and/or their acceptance, use, or misuse of any Prize or element thereof. Parties are not responsible for incomplete or misdirected entries, technical malfunctions or failures, or causes beyond its control. The Released Parties are not responsible for printing or typographical errors or problems in any materials related to the Sweepstakes.

**Publicity:**

**Disputes:**

Except where prohibited, each entrant agrees that: (i) all issues and questions concerning these Official Rules, Terms and Conditions shall be governed exclusively by Nevada law without giving effect to any principles of conflicts of law of any jurisdiction; (ii) any and all disputes, claims and causes of action at law or in equity arising out of or relating to this Sweepstakes or any Prize awarded shall be (A) resolved individually, without resort to any form of class action; and, (B) filed only in the state or federal courts situated in Washoe County, Nevada, and entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and, (iv) under no circumstances will any entrant be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.

**Severability:**

The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
